## Planned COMMUNITY RALLY for STOCKTON BEACH

#### WHAT:

Our strong community VOICE needs to be heard again. Let's remind public agencies exactly what HELP Stockton Beach needs NOW.

#### WHERE/WHEN:

A weekend day this June or July (stay tuned).

#### WHY:

In the 2 years since the last RALLY we have had more TALK, more REPORTS, more EROSION photo opportunities, more CRISIS works, but no real ACTION on the SOLUTION.

#### SOME OF THE LAST 2 YEARS' ACTIVITY:

State has reconfirmed the existence of suitable sand offshore for Mass Sand Nourishment (MSN);

State has funded an investigation into the use of river (harbour) sand;

Council consultants have discounted hard structures such as headlands and offshore reefs; and,

Today, we are left with the option of Mass Sand Nourishment (i.e. lots of sand placed in the beach zone plus annual top off to make sure we have 50+ metres of sand in front of seawalls and scarps).

#### THE PROBLEM:

It is ASPIRATIONAL – no timeline, no funding, no Environmental Impact Statement for sand dredging, no mining lease issued, no permits for sand placing, no plan to buy or lease a dredge, and no plan to build back the beach dune structure.

#### ON THE DAY:

Let's make our community VISIBLE at two key points – on the narrow neck of Corroba Oval and its beach area, and on the Break Water.

Let's show our sports teams and community groups as they stand their ground on our important local places AND line the 1km long State government structure that blocks our sand.

#### **RED T-SHIRTS:**

To show our unity please wear red shirts to the rally. New red t shirts will be available 2 weeks before rally at PPS shop. As a warm up to the RedLineRally2 please wear red tshirts every Saturday from now on.

- 2) Where will the funds come from to pay for Mass Sand Nourishment?
- 3) What is the timeline for MSN to be completed?
